1. Street water pipe Ø225 PEHD along str. "OT 247 – OT 64 – OT 64A – OT 63" from existing water pipe Ø630 to OT 63 – relocation of existing water pipe Ø219/st/from RLP I, quarter 8, district "NPZ Iztok-Karo", Region "Mladost" – Sofia Municipality – put in operation in May 2007. The expenses for the construction works at the site amounted to approximately 105 000.00 levs.

2. Underground transport connection between district "Residential complex Mladost 1" and district "NPZ Iztok-Karo" in RLP I, quarter 95 for the needs of Multifunctional trade and entertainment complex in RLP I, quarter 8, district "NPZ Iztok-Karo" and relocation of existing street water pipe Ø600 from OT 178 to Jerusalem Blvd. at the connection to Tsarigradsko Shosse Blvd. – put in operation in October 2009.
